

KNOW YOUR RIGHTS

HOW TO DEAL WITH POLICE



We are a nation of sovereigns making us all equal under the common LAW (Constitution) and under Almighty God. This is the highest LAW of the land. Every man and woman are duty bound to uphold the COMMON "sense" LAWS: do not cause harm, loss, injury, commit fraud, or breach of the peace.

Any act or statute passed by government must not infringe or interfere with the LAW. That would be UNLAWFUL

Example: The Coronavirus Act 2020 is UNLAWFUL POLICY since it prevents/restricts the freedom to exercise your God given natural rights. This act is NOT LAW.



Police are in **SERVICE** as LAW enforcers to uphold the LAW; to prevent harm, loss, injury, fraud, and breach of the peace. They are sworn in under oath "to uphold the fundamental human rights...cause the peace to be kept and preserved and prevent all offences against people and property...faithfully according to LAW". They are not in service to uphold policy. When police become enforcers of UNLAWFUL POLICY they RELY on you giving your name & address in order to contract with your LEGAL FICTION to EXTORT you.

You are not obliged to give any personal details. You are not committing a crime by lawfully exercising your rights. Instead:

- 1 **ESTABLISH YOUR STANDING** and **DO NOT** allow them to talk. This gives YOU full jurisdiction in this situation.
- 2 **STATE** "You are addressing a flesh and blood man/woman and I am addressing you, a man/woman impersonating a police constable who swore an oath to uphold the LAW".
- 3 **DEMAND** to speak to the DUTY INSPECTOR.
- 4 **INFORM** the duty inspector that you are a man/woman reporting a TRESPASS and will hold the inspector **LIABLE** for the TRESPASS and BREACH of LAW.

If they touch you from this point on it is an **ASSAULT**.
If they take any of your possessions, it is **ROBBERY** (theft is when nobody sees). If they arrest you, it is **KIDNAP**.
NEVER SIGN ANYTHING as they rely on you agreeing to create **JOINDER** with them.

YOU HAVE THE RIGHT TO REMAIN SILENT

- > It's not illegal to refuse to speak to the police, it is your fundamental right not to talk. If you find yourself on the receiving end of police questions, it doesn't matter if they have stopped you in the street, pulled you over for speeding, knocked on your door or are interviewing you down at the station. **Tell them nothing.**
- > You can't be charged with obstruction; perverting the course of justice; resisting arrest or any other offence the officer wants to dream up.
- > Don't profess your innocence, make denials or excuses, argue with them or complain. Your aim should always be to foreshorten any encounter you have with the police.
- > It's not your job to prove your innocence to the police. It is their job to prove your guilt. They are trained to sift through everything you say to find something, anything, that sounds like an admission of guilt. **What you DON'T say will always be easier to defend than what you DO say.**

Be smart. Be safe. Don't talk to the police.
