## **Notice**

It is my understanding that if you continue with attempted extraction of privately earned funds after this correspondence, you may have been given false information by your superiors, had information hidden from you by your superiors, and would also be committing a crime. Due to your duty of obligation to serve and protect the public and public policy can you confirm or deny this please?
- 10. It is my understanding that I am a man and not an artificial entity like JOHN DOE, and as a man and not an artificial entity I am not a citizen, and as a man, who is not a legal fiction and artificial entity, corporative statute policies do not apply to me, they only apply to artificial and public entities like JOHN DOE. Due to your duty of obligation to serve and protect the public and public policy can you confirm or deny this please?
